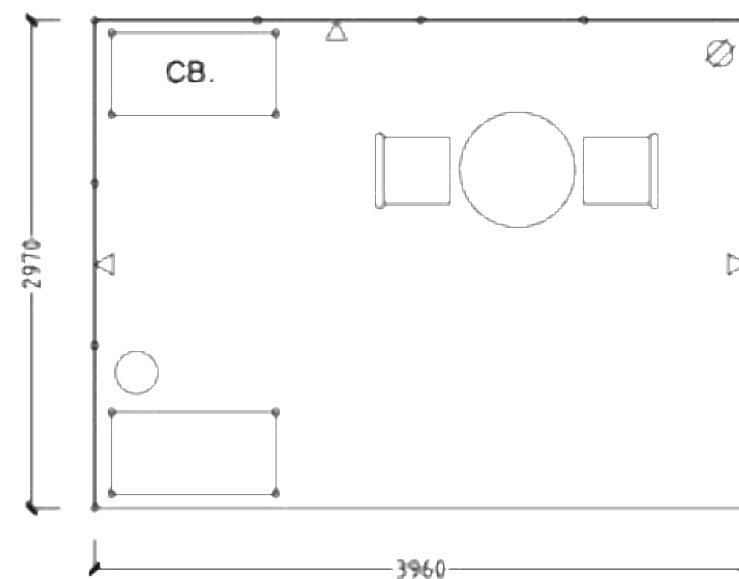

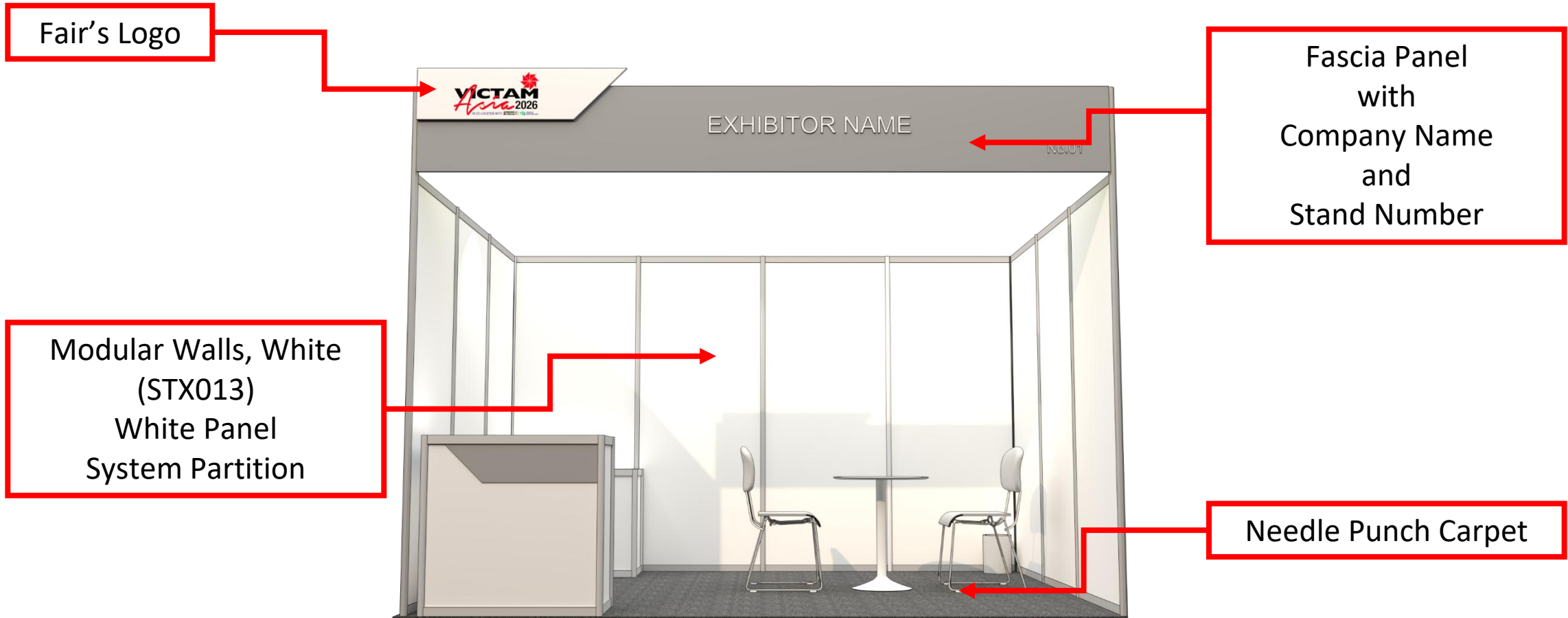

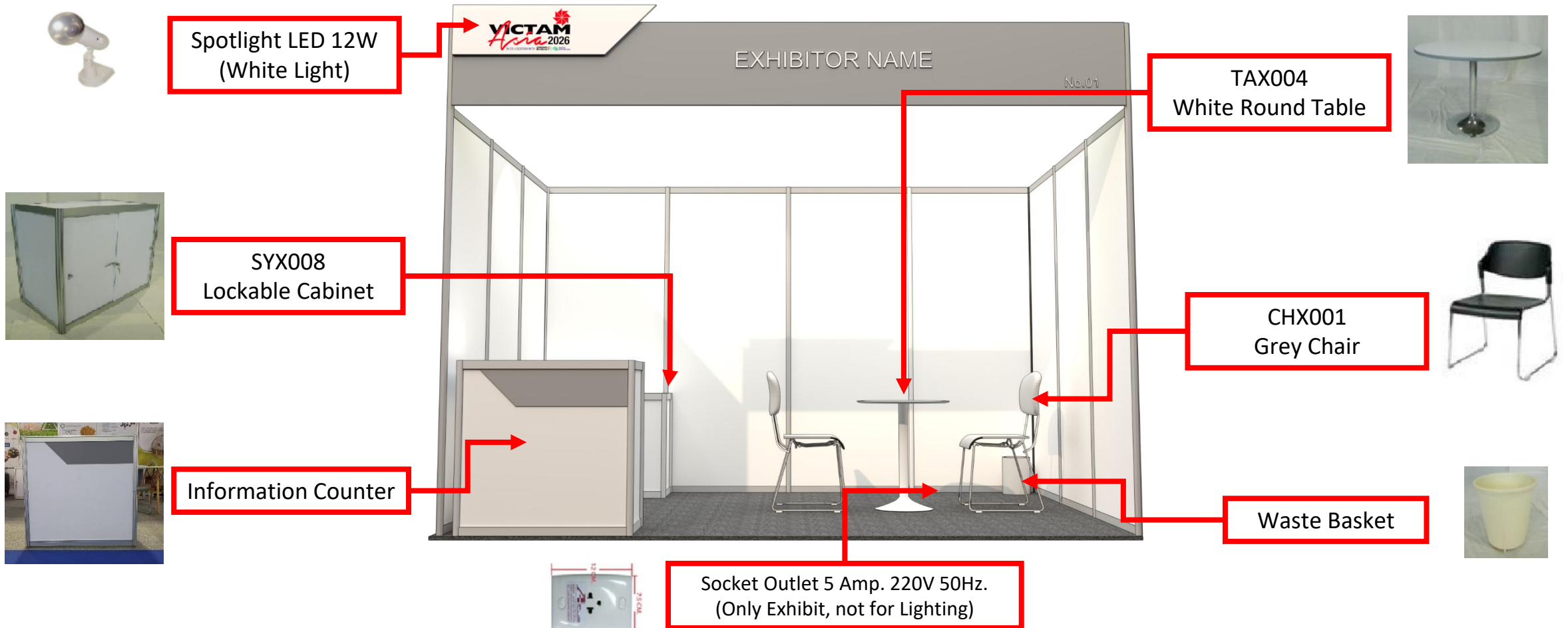
Layout Plan

RULES AND REGULATIONS

STANDARD SHELL SCHEME AND FURITURE SERVICE

1. Do not move, add or change the shell scheme and fascia board. If exhibitors want to make any changes, they must contact XCON CO., LTD.'s staff at the service counter.
2. **Please inspect the quality** of the stand, decorative equipment, furniture and electrical equipment **before using**. In case of any defects or missing parts, kindly contact XCON CO., LTD. service counter in the exhibition venue.
3. **After dismantling, all materials and equipment will belong to XCON CO., LTD.**
4. Standard shell scheme package will not be provided with side panel for the corner booths.
5. System panels between two or more booths under 1 company will be removed. Any removed system panel is not allowed to be used. In case needed, exhibitor can rent for additional from Stand Fittings Service.
6. Any item in standard **shell scheme package cannot be changed to another item**.
7. 1 set of key will be provided for each lockable furniture. In case lost, Baht 350 (Exclude VAT 7%) per 1 set of key will be charged.

8. XCON CO., LTD. only provide booth structure and furniture services rental. Exhibitors shall arrange daily cleaning or place the **order for cleaning service with the venue directly**. Housekeepers will only clean up waste baskets every day after the fair closes.
9. **Booth structure and floating shelf can only handle a maximum weight of 3 kg., XCON will not be held responsible for any injury incase of collapsed structure due to overweight.**
10. **For safety reasons, please do not lean on or place heavy objects on the glass furniture.** XCON CO., LTD. will not be held responsible for any injury or accident occur.
11. **CARRYING AND USING OF FURNITURE FROM NEIGHBORING BOOTH WITHOUT PERMISSION FROM XCON IS STRICTLY PROHIBITED.** Incase exhibitors are caught or if furniture are found in the different booth, **EXHIBITORS WILL BE FINED 5 TIMES OF ON-SITE FURNITURE PRICE LIST.**
12. **Do not use silicone, write, paint or spray the booth panel. Any drilling, nailing, stapling and perforation on the shell scheme panel is strictly prohibited.** Exhibitor will be **fined at the rate of 1,000 THB per panel for any damage.**
13. **Double tape is allowed** to stick on the shell scheme panels and must be **removed after the show ends.**
